Educational MULTIPLE-LOCUS License Agreement For DVD, CD-ROM, Software, Printed Materials, Videodiscs, and Videotapes

MULTIPLE-LOCUS extends the SINGLE-LOCUS License to allow the use of the PRODUCTS in LOCAL AREA NETWORKS, as STAND-ALONE VIDEOS in either digital or analog format, and in CLOSED CIRCUIT SYSTEMS (such as a school building, a school system, a school district or a campus with multiple locations or buildings) within the auspices of the LICENSEE. This MULTIPLE-LOCUS license is limited to the total number of students using the product per the included License Fee Schedule.

Authorized Use
